## Terms of Use

Effective Date: June 26, 2013.

THIS WEBSITE (“SITE”) IS OWNED AND OPERATED BY WEST HELENA BROADCASTERS, INC. AND/OR ONE OF ITS AFFILIATED COMPANIES (COLLECTIVELY, “FORCE 3 RADIO”). THESE TERMS OF USE (“TOU”) GOVERN YOUR ACCESS TO AND USE OF THE SITE. YOU SHOULD CAREFULLY READ THESE TOU. YOUR USE OF THE SITE MEANS THAT YOU HAVE READ AND UNDERSTAND THESE TOU AND THAT YOU HAVE ENTERED INTO A BINDING LEGAL AGREEMENT WITH FORCE 3 RADIO. IF YOU DO NOT ACCEPT AND AGREE TO BE BOUND BY ALL OF THE TERMS AND CONDITIONS OF THESE TOU YOU SHOULD DISCONTINUE YOUR USE OF THE SITE. Force 3 Radio may access your Data to respond to Service or technical problems or as stated in these TOU.

You, not Force 3 Radio, shall have sole responsibility for the accuracy, quality, integrity, legality, reliability, appropriateness and copyright of all Data and Force 3 Radio shall not be responsible or liable for the deletion, correction, destruction, damage, loss or failure to store any Data, or for any actions or omissions which Force 3 Radio takes in reliance upon your Data.

Ownership. Force 3 Radio and/or its licensors own and shall retain all rights, title and interests, including all intellectual property rights, in and to the Site, and all elements thereof. Export.
